- Should furnish the documents of Checklist, Annexure A Status of Receipt and Expenditure of funds Annexure A (Cont.) Permissible activities under Administrative Expenditure and Annexure -B,C and 27 & 29-Checklist.
- Any additional instructions and requirements issued by the State Mission during and after the audit in concurrence with the instructions of Government of India.
