ORDER

The District Vigilance Cells had been constituted as per the Government order read as 1st paper above to investigate various irregularities in the implementation of Mahatma Gandhi NREG Scheme and various irregularities reported as part of its social audit. However, due to the integration of the Local Self Government Department, the post of Assistant Development Commissioner (General), who was head of the Vigilance Cell in the districts, had become extinct.

Mission Director , MGNREGS , as per the letter read as 2nd paper above, in such a scenario has submitted a proposal requesting that the District Vigilance Cells may be reconstituted appropriately in tune with the present set up of the Dept by amending the above Government order. Principal Director, LSGD vide letter read as third paper above has recommended that the charge of the heads of District Vigilance Cells may be given to the Assistant Directors in charge of Administration in the offices of the Joint Directors of LSGD.
